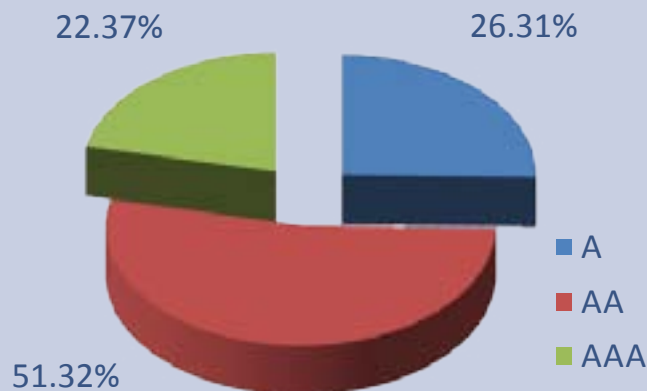

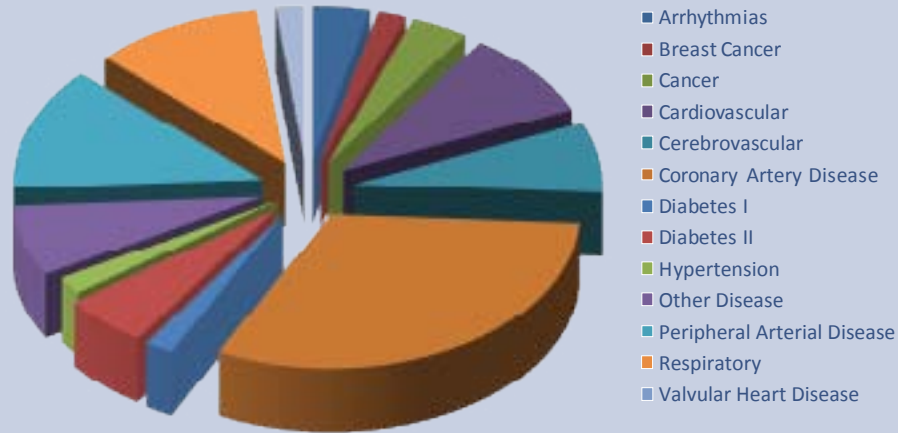
## Life Office Ratings
